MEMBERSHIP CATEGORY

Fees are based on company activity and size. Size is defined in accordance with the European Commission definition of Small and Medium-sized Enterprises based on thresholds for three factors: staff headcount and either turnover or balance sheet total. The thresholds can be found on the [European Union website](#) and here is a summary:

Enterprise category	Headcount: annual work unit (AWU)	Annual turnover	or	Annual balance sheet total
Medium-sized	< 250	≤ EUR 50 million	or	≤ EUR 43 million
Small	< 50	≤ EUR 10 million	or	≤ EUR 10 million
Micro	< 10	≤ EUR 2 million	or	≤ EUR 2 million

The category of micro, small and medium-sized enterprises consists of enterprises which employ fewer than 250 persons; and have either an annual turnover not exceeding EUR 50 million or an annual balance sheet total not exceeding EUR 43 million.

Meeting the staff headcount criterion is mandatory in order to be considered an SME. However, an enterprise may choose to meet either the turnover or the balance sheet total ceiling. It does not need to satisfy both requirements and may exceed one of them without impact on its SME status.

Large Company will be defined as any company above the thresholds defining SMEs.

Membership in this organization shall be composed of any person, corporation, partnership or association engaged in or interested in the polyurea industry, provided that only one membership shall be granted to each business entity. Each subsidiary entity shall secure separate membership. **Anyone qualifying for more than one category of membership will be obligated to pay the highest level of membership.** Please select below the category that best describes your company.
